TERMS OF ADOPTION

Please read the following carefully before signing!

1. I agree that dog or cat is being adopted as a FAMILY PET and will be given EXTENSIVE HOUSE PRIVILEGES, i.e., sleep inside the house, be allowed freedom of the house when the family is home, and will NOT be primarily restricted to the yard. I also agree that dog will or cat never be left unattended in the yard. If I have a swimming pool, I agree to ensure the dog or cat will become pool-safe within 24 hours of final delivery. Animal can not be left outdoors to ensure safety of dog or cat. _____ (Initial)
2. I understand that dog or cat is spayed or neutered. I acknowledge that any other dog or cat in this household is/must be spayed or neutered.
3. I agree that if I cannot keep this dog or cat for any reason that I MUST return cat or dog to Caring Songs For All Creatures and contact Caring Songs For All Creatures IMMEDIATELY to find a suitable home for animal or Foster until we find a permanent home. _____ (Initial)
4. I agree that dog or cat will always be wearing an identification tag.
5. I will give dog or cat proper food, water, shelter and medical treatment when necessary including veterinary care and teeth cleaning.
6. I will keep dog or cat properly groomed and free of fleas, ticks, and other common parasites. I will also monitor skin irritations. I agree NEVER to perform surgery on dog or cat to change his/her appearance – including ear and tail docking.
7. I agree to lock (padlock or key lock) all gates on my property at all times. I also agree to personally supervise meter readers, workers, etc., when entering, leaving or performing tasks in yard or house.
8. For dogs: I agree that dog will never be used as a guard dog. I also will never tie him/her to end of rope or chain regardless of length and under no circumstances will I let dog run unattended in neighborhood. I also agree never to transport him/her in back end of open vehicle.
9. I will notify CARING SONGS IMMEDIATELY if dog or cat is lost or stolen. I will also notify in event of death of dog or cat. _____ (Initial)
10. I will notify CARING SONGS IMMEDIATELY of any change in my address or home/business phone numbers. _____ (Initial)

- 12. UNDER NO CIRCUMSTANCES WILL I EVER PHYSICALLY OR MENTALLY ABUSE DOG OR CAT. Abuse of any kind for any reason will not be tolerated and are grounds for immediate return of dog or cat to CARING SONGS.
- 13. I acknowledge that this agreement will be in effect as of and will continue until notification to CARING SONGS of death or return of dog or cat.
- 14. I agree that adoption fee is non-refundable.
- 15. I understand that CARING SONGS will not be responsible for any liability due to dog or cat's behavior after adoption.
- 16. I understand that CARING SONGS will not be responsible for any expenses incurred after adoption, including medical.
- 17. I will return phone calls to CARING SONGS on status of the dog or cat within 24 to 48 hours and update condition of dog/cat. _____ (Initial)
- 18. I understand that periodic home visits may be requested by CARING SONGS and agree to home visits within 48 to 72 hours of request by CARING SONGS.

_____ I UNDERSTAND THAT FAILURE TO ABIDE BY THE ABOVE TERMS IS A MATERIAL BREACH OF THIS AGREEMENT. I ACKNOWLEDGE THAT DAMAGES IN THE EVENT OF SUCH BREACH OF CONTRACT WOULD BE EXTREMELY DIFFICULT TO DETERMINE AND THEREFORE AGREE TO PAY CARING SONGS FOR ALL CREATURES THE SUM OF \$300.00 PER DOG OR CAT AS DAMAGES FOR ANY SUCH BREACH AND AUTHORIZE CARING SONGS TO RECLAIM THE DOG(S)/CAT(S) IN ADDITION THERETO. I FURTHER UNDERSTAND AND ACKNOWLEDGE THAT CARING SONGS MAY MAKE FOLLOW UP VISITS AND/OR PHONE CALLS TO ASCERTAIN THAT THE ABOVE CONDITIONS ARE BEING SATISFIED.

FOSTER CONTRACT Caring Songs For All Creatures (CSFAC)

Caring Songs For All Creatures Foster Contract This agreement is made and hereby entered into on (Date) _____ by and between Caring Songs For All Creatures, hereafter referred to as CSFAC, and _____, hereafter referred to as Foster for the care of rescued dogs, cats, puppies and kittens awaiting adoption, hereinafter referred to as Foster Dog or Foster Cat.

Both parties agree to the following terms of foster care: Foster agrees to provide housing and care for the dog or cat known as a (color) _____ male/female. Breed: _____

Foster understands and agrees that the foster dog or cat is currently named _____ as it is necessary for record keeping, appointments, public information, etc. to refer to the foster dog by one name and Foster agrees to refer to him or her as such and by no other name either publicly or privately.

Foster agrees to keep this dog or cat as an indoor companion (and for dogs, to keep this dog in a fenced yard or on a leash at all times when outside). Foster agrees not to leave dog or cat unattended outside, either tied up or in a fenced yard when no one is home. All items on the Foster Addendum are included under the terms of this contract.

Foster agrees to provide this dog or cat with proper food, water and loving attention and exercise. Food must be the same brand originally provided by Caring Songs For all Creatures. If Foster wishes to change food brand we are not responsible for reimbursements but can recommend other brands to try. Receipts need to be given to rescue group within 2 weeks in order to receive reimbursement (must be original brand food or recommended by CSFAC in order to receive reimbursement).

CSFAC is NOT responsible for costs of training classes for dog/cat.

Foster agrees to either bring this dog or cat to veterinary appointments, adoption day events, spay or neuter appointments or to allow Caring Songs For All Creatures to make alternate transportation arrangements for these appointments and events to ensure his/her wellbeing to find him/her a forever home. Veterinary care will be handled by vets selected by Caring Songs For All Creatures only. Foster understands that all puppies and kittens will be spayed or neutered prior to adoption as long as they are 8 weeks old or older.

Any medical tests, purchases of medication need to be approved by Caring Songs For All Creatures. _____

Foster agrees that they should not be responsible for adopter selection unless Foster is a volunteer for Caring Songs For All Creatures and has approved meeting with potential adopter through CSFAC.

Foster agrees to return phone call or email messages from Caring Songs For All Creatures within 24 hours. Foster understands that CSFAC retains legal control of this dog or cat and Foster is not authorized to make any legal or medical decisions on his/her behalf. This includes agreeing to administer any medications to the foster dog or cat as directed by CSFAC and/or their veterinarians. If Foster does not administer medications as directed, they must contact rescue to allow for the foster dog/cat to be moved to another foster who can provide medical care. Foster cannot transfer animal to another organization without CSFAC consent.

CSFAC is not responsible for damage statements.

CSFAC is not responsible for injury caused by foster animal.

Adopter can only be approved by CSFAC only.

Equipment purchased by CSFAC for foster is property of CSFAC and needs to be returned when foster animal is no longer living with foster.

If Foster decides to adopt foster animal, Foster must agree to CSFAC adoption procedure and standards.
